The Telephone Company will offer the Long Distance Unlimited Minutes Package at a discounted monthly rate of \$29.99 for customers who are subscribers to the Long Distance Unlimited Minutes Package and new subscribers to **one** of the following affiliate services below for a consecutive six (6) months period. Services must be ordered on the same service order.

- 3 Mg High Speed internet (or higher)
- Basic Video (or higher)

Long Distance Unlimited Minutes Package – Twelve (12) Months

The Telephone Company will offer the Long Distance Unlimited Minutes Package at a discounted monthly rate of \$29.99 for customers who are subscribers to the Long Distance Unlimited Minutes Package and new subscribers to **both** affiliate services below for a consecutive twelve (12) month period. Services must be ordered on the same order.

- 3 Mg High Speed Internet (or higher)
- Basic Video (or higher)

At the end of the specified promotional period, the discounted monthly rate will be converted to the existing monthly rate in effect at that time for the applicable Long Distance Unlimited Minutes Package. The customer will be notified in advance of the rate change in accordance with applicable rules at the end of the specified time frame. A customer's discontinuance of the required services as specified below will result in a conversion of this discounted rate to the current tariff rate for the applicable non-discounted service.

These promotions will be available in all exchange areas where the Telephone Company provides service under the terms and conditions of SC PSC Tariff No. 3. These promotions will end on December 31, 2007.
