The Commission was notified of this promotion by letter dated December 3, 2008. In accordance with Section 5.1, Special Promotions, of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service's South Carolina P.S.C. AT&T All For Less Promotion I

(A) Promotion Description

This promotion is available to AT&T Long Distance Service Business Customers who purchase the AT&T Business Unlimited Flex plan and meet the eligibility requirements listed in (B) herein during the promotion availability period. Qualifying Customers will be charged a promotional monthly recurring charge of \$5.00 per line (“Promotion Benefit”) for the length of the required term agreement in lieu of the monthly recurring charges specified in Section 4.3.3 of the Company’s tariff.

(B) Eligibility Requirements

To be eligible for this promotion Customers must:

- (1) subscribe to the AT&T Business Unlimited Flex plan with one (1) to four (4) lines during the promotion availability period; and,
- (2) meet one of the following conditions:
 - transfer at least one access line from another non-affiliated local service provider to the Company’s affiliated incumbent local exchange company (“Affiliated ILEC”); or,
 - currently subscribe to local dial tone from the Company’s Affiliated ILEC and state an intent to terminate their local dial tone service with that Affiliated ILEC of the Company; and,
- (3) currently or newly subscribe to one of the following services with a minimum two (2)-year term commitment from the Company’s affiliate: Wireless Voice, Wireless Data, Wireless Voice and Data, or a Wireless Laptop Card; and,
- (4) agree that the Company may combine the Company’s wireless affiliate billing with the Company’s wireless billing; and,
- (5) currently or newly subscribe to FastAccess[®] Business DSL, FastAccess[®] Business DSL Plus or FastAccess[®] Business DSL 6.0 provided by the Company’s affiliate; and,
- (6) request to participate in this promotion; and,
- (7) agree to a thirty (36) month AT&T All For Less Subscriber Agreement (“Term Agreement”) for local and long distance service.
