This promotion will begin on January 1, 2009 and will end on August 31, 2009. In accordance with Section 5.1, Special Promotions, of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service's South Carolina P.S.C. Tariff No. 3, the Company will offer the following promotion to business customers:

Business Unlimited Promotion

(A) Promotion Description

This promotion is available to new AT&T Long Distance Customers and to existing Business Message Telecommunications Service (MTS) Customers who subscribe to the Business Unlimited Plan and meet the eligibility requirements listed below during the promotion availability period. Customers will receive a credit equal to 50% off of their Business Unlimited Plan monthly recurring charge for the first six invoices. For partial months, the monthly recurring charge will be prorated.

(B) Eligibility Requirements

- (1) Customers must be a new AT&T Long Distance Customer or an existing MTS Customer and subscribe to the Business Unlimited Plan during the promotion availability period.
- (2) Customers who change from one eligible plan to another during the promotion availability period are not eligible for this promotion's benefits.
- (3) Business Easy Toll Free plan features and monthly recurring charge are not eligible for this promotion's benefits.
