RE: Promotion *Extension* Offered by **BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service**

Dear Mr. Terreni:

This letter is filed on behalf of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service to request to extend the expiration date for the *Business Appreciation Bonus Minutes Promotion* currently available to business customers. The Commission was initially notified of this promotion by letter dated August 28, 2007. This letter filing is submitted in Adobe PDF format and is being filed electronically via the South Carolina PSC E Tariff System. Please acknowledge receipt of this filing by email confirmation.

In accordance with Section 5.1, Special Promotions, of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service's South Carolina P.S.C. Tariff No. 3, the Company proposes to extend the expiration date for this promotion to August 31, 2009, with the requirement that all promotion-eligible services be installed and activated by October 31, 2009. All other terms and conditions associated with this promotion will remain the same.

The specifics of the extended promotion are provided below:

Business Appreciation Bonus Minutes Promotion

(A) Promotion Description

This promotion is available to new AT&T Long Distance Service Business Customers who newly subscribe to the Business Appreciation plan or Business Appreciation II plan and meet the eligibility requirements in (B) herein during the promotion availability period. This promotion will offer 300 free minutes of domestic outbound direct-dialed (1+) or toll-free (inbound) calls per month for up to the first four (4) invoices after enrollment in this promotion. For partial month billing periods the bonus minutes will be prorated.

Business Appreciation Bonus Minutes Promotion, (Cont'd.)

(B) Eligibility Requirements

To be eligible for this promotion Customers must:

- (1) be a new AT&T Long Distance Service Business Customer who newly subscribes to the Business Appreciation plan or Business Appreciation II plan, and;
- (2) at the time of ordering, have local exchange service with a local exchange provider other than the Company's affiliated local exchange company or newly subscribe to local exchange service provided by the Company's affiliated local exchange company in one of the following states: Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina; South Carolina or Tennessee; and,
- (3) commit to a service term agreement with a minimum term commitment of at least thirty-six (36) months with the Company's affiliated local exchange company.

(C) Other Terms and Conditions

- (1) Unused bonus minutes in one month do not carry over to any subsequent monthly billing periods.

(D) Availability

This promotion will begin on September 4, 2007 and will end on August 31, 2009. All services must be activated by October 31, 2009.
