In accordance with Section 5.1, Special Promotions, of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service's South Carolina P.S.C. Tariff No. 3, the Company proposes to extend the expiration date for this promotion to August 31, 2008, with the requirement that all promotion-eligible services be installed and activated by September 30, 2008. All other terms and conditions associated with this promotion will remain the same.

The specifics of the extended promotion are provided below:

**Business Toll Free MRC Waiver Promotion**

**(A) Promotion Description**
