The Company notified the Commission by letter dated December 23, 2008 of its intent to extend the expiration date for this promotion to July 14, 2009. In accordance with Section 5.1, Special Promotions, of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service's South Carolina P.S.C. Tariff No. 3, the Company plans to discontinue the *AT&T Business Bundle Reward Promotion* effective April 30, 2009, with the requirement that all promotion-eligible services be installed and activated by June 30, 2009. All other terms and conditions associated with this promotion will remain the same.

**REVISED AT&T BUSINESS BUNDLE REWARD PROMOTION**

**AT&T Business Bundle Reward Promotion**

**(A) Promotion Description**

Eligible AT&T Long Distance Service (“Company”) Business Customers who newly subscribe to the Business Unlimited Plan during the promotion availability period will receive a reward amount equal to either \$100 or \$250 to be applied towards a reward card (“Promotion Benefit”). The Promotion Benefit will be based on the number of lines to which the Customer subscribes.

**(B) Promotion Benefit:**

<u>Number of Lines</u>	<u>Reward Amount</u>
1 line	\$100
2 or more lines	\$250

**(C) Eligibility Requirements:**

During the promotion availability period, Customers must :

- (1) newly subscribe to the Business Unlimited Plan; and,
- (2) newly subscribe to Complete Choice<sup>®</sup> for Business service provided by the Company’s affiliated incumbent local exchange company (“Affiliated ILEC”) and commit to a local term agreement for this service; and,
- (3) previously subscribed to local dial tone service from the Company’s Affiliated ILEC and are returning to the Company’s Affiliated ILEC for their local service or currently have all of their local service with a local provider that is not an affiliate of the Company; and,
- (4) newly subscribe to FastAccess<sup>®</sup> Business DSL, FastAccess<sup>®</sup> Business DSL Plus or FastAccess<sup>®</sup> Business DSL 6.0 provided by the Company’s Affiliated ILEC and commit to a minimum thirty-six (36) month term agreement for the qualifying FastAccess<sup>®</sup> DSL service; or,
- (5) newly subscribe to AT&T High Speed Internet U-verse Enable 1.5, 3.0, 6.0 or 10.0 (where available) provided by the Company’s Affiliated ILEC and agree to a twelve (12) month agreement for qualifying AT&T High Speed Internet U-verse Enable service.

**(D) Other Terms and Conditions**

- (1) Customer is only eligible for one reward amount. Eligible multi-location customers can only have one location participate in this offer and is only eligible to receive one reward amount.
- (2) This promotion may not be combined with any other promotion except for the Business Advantage Promotion.
- (3) Where Customer qualifies for a corresponding reward card promotion from affiliates of the Company, the Company may provide Customer with a single, combined Reward Card.

**(E) Promotion Availability**

This promotion will be available beginning July 15, 2008 and ending ~~July 14, 2009~~ April 30, 2009. All services must be activated by ~~September 14, 2009~~ June 30, 2009.
