This letter is filed on behalf of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service to advise the Commission of a special promotion the Company intends to offer within the State of South Carolina. This promotion will begin on May 1, 2009 and will end on August 31, 2009. This letter filing is submitted in Adobe PDF format and is being filed electronically via the South Carolina PSC E Tariff System. Please acknowledge receipt of this filing by email confirmation.

In accordance with Section 5.1, Special Promotions, of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service's South Carolina P.S.C. Tariff No. 3, the Company will offer the following promotion to business customers:

AT&T Business Bundle Reward Promotion II

(A) Promotion Description

Eligible AT&T Long Distance Service ("Company") Business Customers who newly subscribe to the Business Unlimited Plan during the promotion availability period will receive a reward amount equal to either \$100 or \$225 to be applied towards a reward card ("Promotion Benefit"). The Promotion Benefit will be based on the number of lines to which the Customer subscribes.

(B) Promotion Benefit:

1 line	\$100
2 or more lines	\$225

(C) Eligibility Requirements:

During the promotion availability period, Customers must :

- (1) newly subscribe to the Business Unlimited Plan; and,
- (2) newly subscribe to Complete Choice[®] for Business service provided by the Company's affiliated incumbent local exchange carrier ("Affiliated ILEC"); and,
- (3) previously subscribed to local dial tone service from the Company's Affiliated ILEC and are returning to the Company's Affiliated ILEC for their local service or currently have all of their local service with a local provider that is not an affiliate of the Company; and,
- (4) newly subscribe to FastAccess[®] Business DSL, FastAccess[®] Business DSL Plus or FastAccess[®] Business DSL 6.0 provided by the Company's Affiliated ILEC and commit to a minimum thirty-six (36) month term agreement for the qualifying FastAccess[®] DSL service; or,
- (5) newly subscribe to AT&T High Speed Internet U-verse Enable 1.5, 3.0, 6.0 or 10.0 (where available) provided by the Company's Affiliated ILEC and agree to a twelve (12) month agreement for qualifying AT&T High Speed Internet U-verse Enable service.

(D) Other Terms and Conditions

- (1) Customer is only eligible for one reward amount. Eligible multi-location customers can only have one location participate in this offer and is only eligible to receive one reward amount.
- (2) This promotion may not be combined with any other promotion except for the Business Advantage Promotion.
- (3) Where Customer qualifies for a corresponding reward card promotion from affiliates of the Company, the Company may provide Customer with a single, combined Reward Card.

(E) Promotion Availability

This promotion will be available beginning May 1, 2009 and ending August 31, 2009. All services must be activated by October 31, 2009.
