This letter is filed on behalf of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service to request an extension of the *AT&T One Rate[®] Nationwide 5 Cents Preferred Promotion* [formerly named *BellSouth[®] Nickel Savings Value Promotion*] currently available to residential customers. This letter filing is submitted in Adobe PDF format and is being filed electronically via the South Carolina PSC E Tariff System. Please acknowledge receipt of this filing by email confirmation.

In accordance with Section 5.1, Special Promotions, of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service's South Carolina P.S.C. Tariff No. 3, the Company proposes to extend the expiration date for this promotion to October 31, 2008. All other terms and conditions associated with this promotion will remain the same.

The specifics of the extended promotion are provided below:

AT&T One Rate[®] Nationwide 5 Cents Preferred Promotion

(A) Promotion Description

For purposes of this promotion the Company defines new Customers as all Customers who have not subscribed to any AT&T Long Distance services within 5 days prior to enrollment in this promotion.
