6. Switched Access Service

6.1 General

The Telephone Company adopts, for intrastate Switched Access Services, Section 4 of the Frontier Telephone Companies Tariff FCC No. 5, Facilities for Interstate Access, effective as of July 2, 2013, and any successive issues thereto.
