An existing residential customer is eligible to receive the Long Distance Package – Unlimited Minutes Triple Pak at a retention offer discounted monthly rate when the customer decides to remain with the Company and subscribes to a 24 month term commitment. The customer must be in good standing with the Company by timely payment of the previous six months bills. The options in this offering must consist of:

- Long Distance Package – Unlimited Minutes Triple Pak service on primary lines,
- Digital Video Service (specific tier determined at the discretion of the Company),
- High Speed Internet (HSI) Service (specific speed determined at the discretion of the Company).

The Long Distance Package – Unlimited Minutes Triple Pak includes telephone service consisting of basic service for one primary line as well as the following features: Anonymous Call Rejection; Caller ID; Call Forwarding – Selective; Call Forwarding – Variable; Call Screening; Call Waiting with Caller ID; Call Waiting/Cancel Call Waiting; Custom Ring; Selective Call Acceptance; Speed Dial 8. Service also includes Company unlimited long distance (Includes continental US, Alaska, Hawaii, Canada and Puerto Rico). No substitution of any service within this package is allowed.

Wire maintenance service is also included as part of this retention offer.

The rate will apply for the entire 24 month term from the date it is implemented on the customer's account. At the conclusion of the 24 month term, the customer may renew participation in this discount plan at the rate and terms then in effect. Discontinuance of any one of the services listed above will result in immediate termination of the discount. The Customer's discontinuance of one of the required affiliate services will result in a conversion to the current rate for the Long Distance Package – Unlimited Minutes Double Pak. The customer's discontinuance of both of the required affiliate services or opting out (see below) of this discount plan will result in a conversion to the current non-discounted rate for the Long Distance Minutes Package.

Availability of this service is limited to where service is technically feasible.
