Dear Mr. Terreni:

Enclosed for filing please find the revised local tariff pages filed on behalf of Talk America Inc. This tariff revision revises certain nonrecurring charges as follows: (1) reduces the Line Change Charge for residential lines and eliminates the charge for additional lines on the same order for business and residential accounts; (2) introduces a text change for Line Change Charges and maintains the current charge associated with changing telephone numbers. (3) increases the PIC Change Charge; and (4) reduces the Restoral Charge for all business lines on an account and for residential initial lines, and raises the charge for residential additional lines on an account.

The Company's customers are being notified of these changes. The Company respectfully requests an effective date of October 1, 2008.
