S4.2 APPLICATION (continued)

S4.2.5 Restoration Charge

- a. The restoration Charge is applicable for restoral of service following a temporary suspension of such service due to non-payment. Restoration Charge is equal to the total of the Secondary Service Order Charge and the Central Office Work Charge.

S4.2.6 Services Change Charge

- a. The Services Change Charge applies each time a change to a current customer's service is made at the request of the customer. The Secondary Service Order Charge will not apply when the Services Change Charge applies.
