Enclosed for filing, please find revisions to the United Telephone Company of the Carolinas LLC d/b/a CenturyLink Intrastate/InterLATA Services Tariff and General Subscriber Services Tariff. These revisions are submitted with a July 15, 2015 issue date and a proposed effective date of July 22, 2015.

The tariff page enclosed for review and approval are listed in Attachment A.

This filing deletes Asynchronous Transfer Mode (ATM) Service. There are no customers subscribed to this service and deletion of this service does not impact customers.

This filing also proposes the discontinuance of month-to-month Frame Relay and Enhanced Frame Relay Services and grandfathers customers currently subscribed under a term discount plan.

The equipment necessary to provide ATM Service, Frame Relay Service and Enhanced Frame Relay Service is no longer manufactured or supported by the vendor. Frame Relay and Enhanced Frame Relay Service will therefore be discontinued for customers who are subscribed to the services on a month-to-month basis. Customers currently subscribed under a term commitment period may retain service for the duration of the current term commitment period, but may discontinue service at any time without incurring termination liability charges.

Customers have been notified of the discontinuance of Frame Relay and Enhanced Frame Relay Services due to the equipment obsolescence and of their need to select alternative technologies. .
