This letter is filed on behalf of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service to request an extension of the *Business Unlimited Flex 50% Off Promotion II* currently available to business customers. The Commission was initially notified of the reintroduction of this promotion by letter dated April 25, 2008. This letter filing is submitted in Adobe PDF format and is being filed electronically via the South Carolina PSC E Tariff System. Please acknowledge receipt of this filing by email confirmation.

In accordance with Section 5.1, Special Promotions, of BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service's South Carolina P.S.C. Tariff No. 3, the Company proposes to extend the expiration date for this promotion to December 31, 2008, with the requirement that all promotion-eligible services be installed and activated by February 28, 2009. All other terms and conditions associated with this promotion will remain the same.

The specifics of the extended promotion are as follows:

Business Unlimited Flex 50% Off Promotion II

(A) Promotion Description

This promotion is available to new AT&T Long Distance Customers and to existing Message Telecommunications Service (MTS) Customers who subscribe to the Business Unlimited Flex plan and meet the eligibility requirements listed below during the promotion availability period. Customers will receive a credit equal to 50% off of their Business Unlimited Flex plan monthly recurring charge for the first four invoices. For partial months, the monthly recurring charge will be prorated.

(B) Eligibility Requirements:

- (1) Customers must be a new AT&T Long Distance Customer or an existing MTS Customer and subscribe to the Business Unlimited Flex plan during the promotion availability period.
- (2) Customers who change from one eligible plan to another during the promotion availability period are not eligible for this promotion's benefits.
- (3) Business Easy Toll Free plan features and monthly recurring charge are not eligible for this promotion's benefits.

(C) This promotion will begin on May 1, 2008 and will end on December 31, 2008. All services must be activated by February 28, 2009.
